We worked with more groups than ever including:





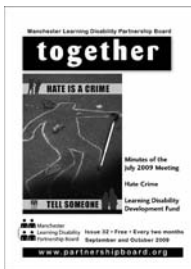
service audit project |

Since August 2007 we have run a project to inspect services for learning disabled people on behalf of the Joint Commissioning Team. We employ 4 adults with learning disabilities to do this work. So far, we have inspected 36 houses, managed by 7 different service providers.



partnership board |
